The above amounts will determine your weekly tuition payment. Payments are due Mondays of each week for the following weeks of care by 5:00 PM. Tuition is calculated for the schedule/contract of care you have chosen for your child. It is in effect during the entire contract time, unless a schedule change is submitted and approved. Tuition is not reduced because of scheduled holidays, illness, or absence. Vacation time may be used if applicable. (Refer to the parent handbook). Fees are subject to change; a minimum notification of 30 days will be given.

- **Your contract hours are your child's hours of attendance; please follow these contract hours to avoid a late pick up or early drop off fee. If there are times that you need to change your child's attendance times, please see Janell**
 - **If a portion of the fee will be paid by a third party, such as an employer or the county, that payment will be accepted on a separately arranged schedule, described on the contract.**
 - **The financial terms will be finalized upon signing of the parent-provider contract.**
 - **If a parent or legal guardian is under age 18, a cosigner must sign the contract to act as guarantor to the contract and agree to be bound by all financial terms.**
 - **Families will receive a minimum of 6-week notice when a rate increase is planned.**
 - **Sibling Discount: 10%**

Other Fees:

Hourly rate for extra hours or drop-in care: \$14.00 per hour (outside of contracted hours)

Field Trips: will be posted per trip (a portion of Supply/Activity Fees is applied to to this)

Enrollment/Annual Re-Enrollment Fee: \$100 Paid Yearly each Sept 1 (applies to Supply/Activity Fees)

Fee for late pick up of child: After program closes at 5:00 PM, \$5 is charged for 1st 5 min (from 5:00-5:05 PM), \$10 is charged for each additional 5 minutes (after 5:05 PM and later)

Fee for late payment. Fees are to be paid in advance on Monday by 5:00 PM each week for the following week's services. If a payment is more than 3 days late, including weekend days, this fee will be charged for each day payment is not made (including the 5 days already past): \$20 per day.

Fee for non-sufficient funds (NSF) or overdrafts. You will be charged an additional fee of \$25.00 if your check does not clear the bank.
